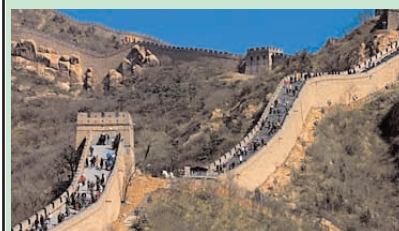

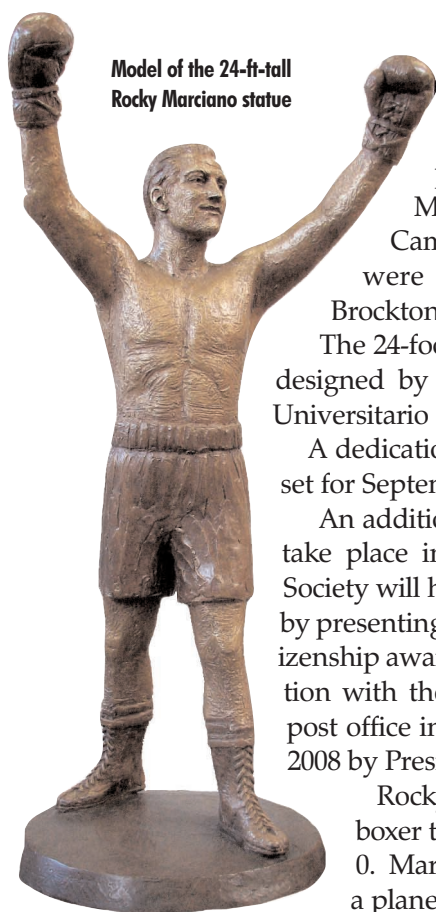

After much discussion and debate, it has been announced that the Rocky Marciano Statue, donated by the World Boxing Council, will be placed at Brockton High School's Marciano Stadium, across from Campanelli Stadium. Prior sites considered were Boston and the GAR Park outside Brockton City Hall.

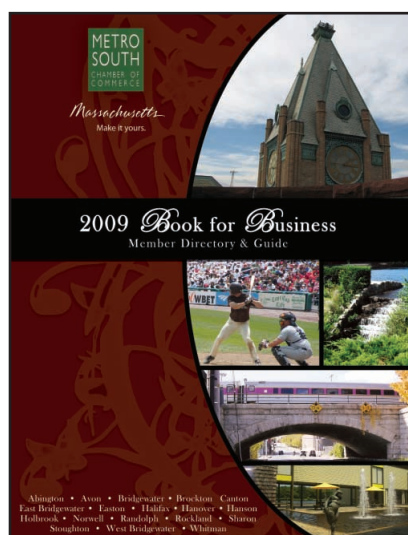
The 24-foot bronze statue, atop a 2-foot base was designed by Mario Rendon, head of the Instituto Universitario de las Bellas Artes in Colima, Mexico.

A dedication ceremony of the statue is tentatively set for September 1, the boxing legend's birthday.

An additional ceremony for Rocky Marciano will take place in April when the Brockton Historical Society will honor Rocky for his role in local history by presenting Marciano's family with the historic citizenship award. This event is happening in conjunction with the dedication of the Commercial Street post office in honor of Marciano in a bill signing in 2008 by President Bush.

Rocky Marciano was the only heavyweight boxer to retire undefeated with a record of 49-0. Marciano, born in 1923 in Brockton, died in a plane crash in 1969.

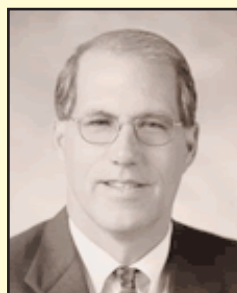

## Workers May Qualify for EITC

Metro South Chamber of Commerce is proud to partner with Mayor James Harrington's Earned Income Tax Campaign for 2009. Free electronic tax preparation and filing is available at the Harbor One Multi Cultural Center, 68 Legion Parkway in Downtown Brockton on Monday evenings from 4-7 pm starting Feb. 2nd.



Assistance on Saturdays will be provided from 9-3 at the Self Help Fuel assistance site, 1362 Main Street in Campello beginning Jan. 31st.

Preparation and filing will be done on a first come first served basis. Please bring a photo ID, Social Security card for you and your dependents and all earned income statements, i.e. W-2s and 1099s.

This program is designed to help working families and individuals with low and moderate income take advantage of the Earned Income Credit (EIC) as well as the Child Tax Credit (CTC).

With both the federal and state tax credits, workers may get up to \$4,700 in refunds. Workers can

claim both the federal and state EITC, even if they do not owe income tax, simply by filing federal and state income tax returns. You will receive a state credit equal to 15% of the federal amount. Millions of eligible workers risk missing out on these important federal tax benefits which are also matched to a lesser degree by the state.

### Who Is Eligible?

- Workers who were raising one child in their home and had income of less than \$33,241 (or \$35,241 for married workers) in 2008 can get an EIC of up to \$2,853.

- Workers who were raising more than one child in their home and had income of less than \$36,348 (or \$39,783) for married workers) in 2007 can get an EIC of up to \$4,716.

- Workers who were not raising children in their home, were between ages 25 and 64 on December 31, 2008, and had income below \$12,590 (or \$14,590 for married workers) can get an EIC up to \$428.
