State Senator Michael Rodrigues, Chair, Ways & Means Committee

State Senator Michael J. Rodrigues was elected to the Massachusetts State Senate in 2010, and serves the First Bristol and Plymouth District, which includes Westport, Fall River, Freetown, Lakeville, Rochester, Somerset, and Swansea. He was appointed as Chair of the Senate Committee on Ways and Means, as well as the Vice Chair of the Senate Committee on Steering and Policy for the 2019-2020 legislative session. In the 2017-2018 session, he served as Senate Majority Whip, Chairman of the Senate Committee on Ethics, and Vice Chairman of the Senate Committee on Redistricting,

In addition, Capstone is finishing The McElwain School Apartments, a 57 unit mixed-income development in Bridgewater that includes Passive House and historic construction.

Jason is a Director of CHAPA and a Director of 2Life Communities. Jason received an MS from the Massachusetts Institute of Technology's Center for Real Estate and a BA from the University of Michigan, Ann Arbor. Jason's MIT thesis, The Low-Income Housing Tax Credit: HERA, ARRA, and Beyond has been cited by Harvard University's Joint Center for Housing Studies and the US Senate Budget Committee.





Suárez-Orozco is the ninth Marcelo permanent and current chancellor of the University of Massachusetts Boston, and is the first Latino to lead a campus in the Massachusetts public university system. He is the former inaugural UCLA Wasserman Dean at UCLA Graduate School of Education and Information Studies.

Chancellor Marcelo Suárez-Orozco assumed the role of chancellor of the University of Massachusetts Boston on August 1, 2020. Prior to coming to UMass Boston Suárez-Orozco served as the inaugural UCLA Wasserman Dean, leading two academic departments, 16 nationally renowned research institutes, and two innovative demonstration schools at UCLA's Graduate School of Education & Information Studies. His research focuses on cultural psychology and psychological anthropology, with an emphasis on education, globalization, and migration. His award-winning books and edited volumes

have been published by Harvard University Press, Stanford University Press, University of California Press, Cambridge University Press, New York University Press, and others.

A member of the American Academy of Arts and Sciences (currently serving in the Governance and Trust Board), the National Academy of Education, Trustee of the Carnegie Foundation for the Advancement of Teaching, member of the Board of Advisors of the Thomas Mann House, and recipient of Mexican Order of the Aztec Eagle, Dr. Suárez-Orozco has served as Special Advisor to the Chief Prosecutor, The International Criminal Court, The Hague, The Netherlands.

In January of 2018 His Holiness Pope Francis appointed Suárez-Orozco to the Executive Committee of the Pontifical Academy of Social Sciences and on July 4, 2018 the Carnegie Corporation of New York named him a "Great Immigrant / Great American."

An immigrant from Argentina, Dr. Suárez-Orozco is a product of the California master plan having studied in community college and at the University of California Berkeley, where he received his AB, MA, and PhD (anthropology) in 1986.





The Small Business Bill of Rights summarize the basic rights of business owners in America—and represent policies the U.S. Chamber supports and fights for every day.

In a nation built by entrepreneurs and driven by free enterprise, small businesses should have the freedom to hire, innovate, grow, and strengthen their local economies and communities. We're calling on elected officials to foster their freedom to exist and thrive by upholding these basic rights for founders, entrepreneurs, and small business owners:

I. The right to a competitive and available workforce.

Fueled by the energy and talent of workers, small businesses respond to the marketplace, meet customer needs, solve fast-changing problems, and foster dynamic and flexible workplaces. The government should advance policies that strengthen the workforce and help address the labor shortage, such as through legal immigration reform.

II. The right to run a business free from government interference.

Small businesses are by necessity nimble, adaptive, and innovative. Heavy-handed regulations that put business decisions under the control of the government undermines the business owners' freedom and flexibility to run and grow their companies and service their customers.

III. The right to operate without fear of lawsuit abuse.

For a small business, one frivolous lawsuit can mean bankruptcy. Elected leaders must commit to clamping down on profit-based litigation and extortionary practices through commonsense legal reform.

IV. The right to be rewarded for their hard work.

The promise of a profit rewards entrepreneurs' hard work and makes it possible to keep a business going. The government should not dictate how small businesses invest, direct, or share their hard-earned rewards to take a growing cut to fuel government spending.

V. The right to take a risk.

Entrepreneurs, small business owners, and founders are among the most courageous in our economy - many put everyone on the line in pursuit of an idea or a dream. Policies, rules and regulations that undermine competition and erode our free enterprise system threaten the risk-reward proposition that drives people to start, invent, solve, grow, and strengthen society.
