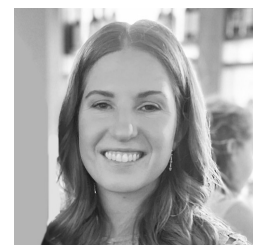

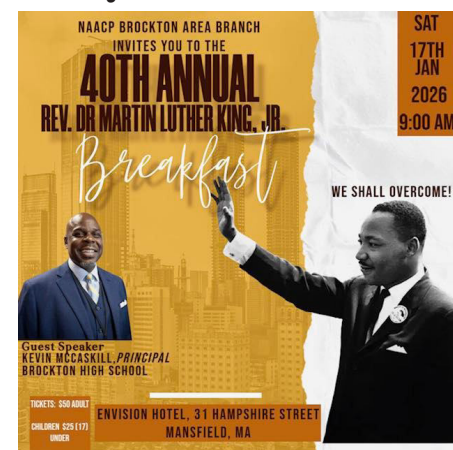

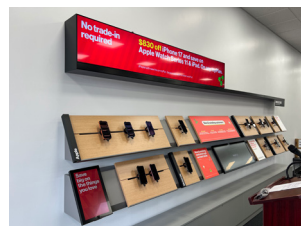

Guest speaker Dr. Mark Melnik, Director of Economic & Public Policy Research at UMass Donahue Institute, shared a data-driven look at the Massachusetts economy, highlighting slow growth, labor market stabilization, high costs of living, and demographic challenges shaping the year ahead. His insights offered attendees a valuable perspective on regional economic trends and opportunities for business and community leaders.

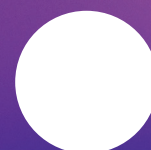

Father Bill’s & MainSpring Celebrates Completion of 24-Unit Housing Development in Stoughton



The \$10.5 million redevelopment of the 3.88-acre property, formerly the Stoughton Motel, began in March 2025 and includes three buildings with 12,100 square feet of living space. Two units are fully wheelchair accessible, and FBMS case managers will provide on-site supportive services to help residents maintain long-term housing stability.

The project creates 24 studio efficiency apartments at 1919 Washington Street, providing permanent supportive housing for individuals who have experienced homelessness. The development is expected to welcome tenants this winter. The new housing comes at a critical time as individual homelessness continues to rise locally and statewide, up 26% from FY24. 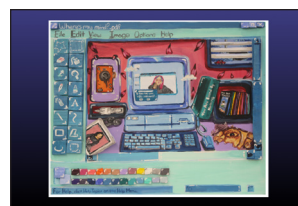

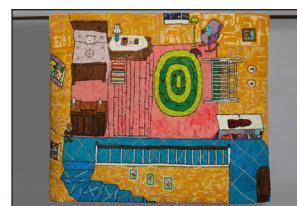
